ON THE STREET WHERE YOU LIVE...

Now days Union Street divides our numbered streets into east this or west that. But in 1860 Union was the outer western edge of the city. Then along came Victor Trevitt, who subdivided his parcel of land to the immediate west and created what would be called the Trevitt Addition. The western edge of this new addition would eventually be named Lincoln Street after the man who would become our 16th President the following year... Eventually.

Victor Trevitt was a "get 'er done" kind of guy, a bit of an iconoclast, but mostly a conservative. It was the lead up to the Civil War, political lines were pretty clearly drawn and this was a time when Republicans were the liberals and the supporters of federal government and Abraham Lincoln. The south was full of southern Democrats and states rights. Into this mix comes Mr. Trevitt and his addition.

Well, it seems that in the official plat map he filed, he had just extended the numbered, east/west streets that already existed in town but had somehow neglected to put down names for the new, north/south streets. Having moved on to his next project, he couldn't be bothered so he told the city planners to fill them in as they saw fit. The problem with this approach centered upon this large political rift... to play a joke on Democrat Trevitt, his Republican friend on the planning commission named them Liberty and Lincoln, thus forever immortalizing the republican campaign slogan of "Lincoln, Liberty & Union" into the Trevitt addition. I don't know about you but I miss these kind of shenanigans in our politics.

(now I know that some of you have been around so long that some of the local history seems like yesterday's news, but there are some of us who are late incomers to the area and we love stories like this ... so bear with us.)

Also, it should be noted that although the Courthouse Museum is located in the Trevitt Addition (if you wish to pick this particular nit...) the area should be

called something like the Trevitt Addition Addition. The original plat, filed in 1860 only went as far west as the lots along Lincoln Street. In 1878 Trevitt filed an extension which included the land from Lincoln Street clear to the banks of Mill Creek. This facilitated the creation of a new street named after Robert Pentland who operated a flour mill at the end of West Third Street along the banks of the creek, and laid out the first water system in The Dalles. Starting around West Fourth and Pentland, The Dalles and Sandy Wagon Road headed west to the Portland area. Oh, and John Jacob Zimmerman purchased the lots at the beginning of West Second Place, where our Museum now resides.
