We just finished up the Wasco Cultural Trust grant which funded the creation of the carpenter shop exhibit in the Zimmerman Shop building out behind the Courthouse. The Shop is kind of a fascinating building. Original to the property, it once housed John Zimmerman's carpenter shop, a root cellar, an outhouse (later converted to a bathroom), and a wood shed. A real multi-purpose building! When we cleaned the place out decades ago, just after the Courthouse was moved to its current location, we found and preserved Zimmerman's work bench, as well as a few remaining tools. These original objects now make up the core of the new exhibit, along with reproduction and antique tools, put together to show what a working turn of the century carpenter shop would have looked like. All hand tools!

We have the programs lined up for the Vercouteren Regional History Forum, see the list elsewhere in this newsletter. This year we will also have a Bonus Program on the first Saturday of March. This will give us one more chance to get together one more time before spring comes, and an additional opportunity to learn more about our local history. We are also thinking about additional ways to engage our community and bring more visitors into the Original Courthouse, maybe something like live musical performances during the summer?

As always, the board continues its work to keep the place shipshape and viable.

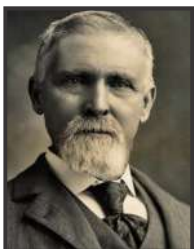
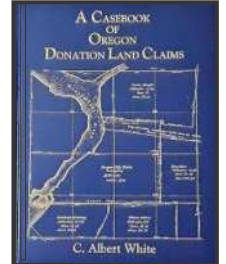

The Boys of '61-Robert Pollock

This talk will focus on the history and legacy of the Grand Army of the Republic, or G.A.R. as it was often referred to. Mostly forgotten today, the G.A.R. was once a large and politically powerful nationwide organization made up of veterans of the Civil War. At its peak in 1890, the G.A.R. had a membership of over 400,000. In The Dalles, the J.W. Nesmith Post No. 32 was established in 1885.
